

**THE GRATEFUL TABLE DINE OUT SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM THE PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. MANY WILL ENTER, ONLY TWO WILL WIN IN EACH SWEEPSTAKES; EIGHT TOTAL. VOID WHERE PROHIBITED. ODDS OF WINNING DEPEND ON NUMBER OF ELIGIBLE ENTRIES RECEIVED. ENTRY OPEN ONLY TO LEGAL RESIDENTS CALIFORNIA WHO ARE AT LEAST EIGHTEEN (18) YEARS OF AGE. VOID WHERE PROHIBITED BY LAW.

The Grateful Table Dine Out Sweepstakes ("Sweepstakes") is sponsored by the California Restaurant Foundation ("Sponsor"), 621 Capitol Mall, Suite 2000, Sacramento, CA 95814.

1. SWEEPSTAKES PERIOD: There are a total of four (4) Sweepstakes. Sweepstakes period 1 begins November 1, 2021 at 12:00 a.m. Pacific Time (PT) and ends on November 4 at 11:59:59 p.m. PT. Sweepstakes period 2 begins November 5, 2021 at 12:00 a.m. Pacific Time (PT) and ends on November 11 at 11:59:59 p.m. PT. Sweepstakes period 3 begins November 12, 2021 at 12:00 a.m. Pacific Time (PT) and ends on November 18 at 11:59:59 p.m. PT. Sweepstakes period 4 begins November 19, 2021 at 12:00 a.m. Pacific Time (PT) and ends on November 25 at 11:59:59 p.m. (PT). The Sponsor's computer is the Sweepstakes official clock.

2. ELIGIBILITY: This Sweepstakes is open only to legal residents of California who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, and its respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

3. HOW TO ENTER: During a Sweepstakes Period, an eligible entrant must follow the steps below to receive one (1) Sweepstakes entry ("Entry"):

- i. Sign into your non-private Instagram or Twitter account; and
- ii. Follow @RestaurantsCare on Instagram or Twitter
- iii. In the comments on the photo that says "\$200 to your favorite restaurant" (b) tag your favorite restaurant. You must not inaccurately tag content, and the restaurant must be located in California. (c) tag a person you would like to share a meal with. By completing the above steps during a Sweepstakes Period, you will receive one (1) Entry into the Sweepstakes.

NOTE: A purchase is not required to enter or win. The content included in the Entry will not be judged or used in any way to determine a winner. By entering the Sweepstakes, the entrant hereby agrees to

be bound by these Official Rules. Entries will be deemed made by the authorized account holder of the Instagram or Twitter account the entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Instagram and Twitter by the online service provider. In the event a dispute arises as to the identity of a potentially winning entrant, entries will be declared made by the account holder as determined by Sponsor. If the identity of the person submitting an Entry cannot be resolved to Sponsor’s satisfaction, the affected Entry will be deemed ineligible. An entrant must have a non-private Instagram or Twitter account to enter the Sweepstakes. If an entrant does not have a non-private Instagram or Twitter account, entrants may create an Instagram or Twitter account at no cost. Creation of an Instagram or Twitter account requires a contestant to agree to Instagram’s or Twitter’s Terms of Service and Privacy Policy respectively. If an entrant enters from his/her wireless phone, the entrant’s wireless service provider may charge the entrant. Entrants should consult their wireless-service providers regarding their pricing plans. Message and data rates may apply. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Instagram or Twitter.

Entry Requirements: All Entries must comply with the following restrictions:

- Entry must follow @RestaurantsCare on Instagram or Twitter
- Entry must include a tag to your favorite restaurant
- Entry must include a tag of one other person
- Entry must comply with Instagram or Twitter terms of service

ENTRY CONTENT LIMITATIONS: Entries may not contain, and Sponsor may remove or disqualify in its sole discretion at any time, any entry containing content it deems inappropriate or unsuitable, including without limitation any offensive, indecent, profane, obscene, hateful, illegal, tortious, defamatory, violent, threatening or harassing content. Entries must be suitable for public viewing by all ages and in keeping with Sponsor’s image. Entries must not contain viruses or any other computer code that may damage or interfere with any computer or system, or intercept or collect any data. Entries may not contain content for which you were or expect to be compensated or granted any benefits by any other person or entity. Entries cannot have been published by any party other than the entrant. Entry cannot prominently feature trademarks or logos owned by a third party, unless logos/images are from the restaurant tagged in the entry. The Sponsor may disqualify or remove entries at any time in its sole discretion.

IMPORTANT: MESSAGE AND DATA RATES MAY APPLY IF AN ENTRANT ENTERS THIS SWEEPSTAKES ON HIS/HER MOBILE DEVICE. NOT ALL MOBILE TELEPHONE/WIRELESS PROVIDERS CARRY THE SERVICE NECESSARY TO PARTICIPATE IN THIS SWEEPSTAKES. ENTRANTS SHOULD CONSULT THEIR WIRELESS PROVIDER’S PRICING PLANS. MOBILE ENTRY IS NOT REQUIRED TO ENTER OR WIN THE PRIZE IN THIS SWEEPSTAKES.

LIMIT: There is a limit of one (1) Entry per person, per week during each of the Sweepstakes Periods (limit 4 total) on Twitter and a limit of one (1) Entry per person, per week during the Sweepstakes Period (limit 4 total) on Instagram. Between the two platforms, a person may enter the sweepstakes 8 times. If an entrant enters more than one (1) entry per day per platform, only the first entry will be included in the Sweepstakes. Anyone found to use multiple accounts to enter will be ineligible and all Entries will be disqualified. You may enter a Sweepstakes only by following the instructions as set forth herein (which permits eight (8) Entries per Sweepstakes Period). There is a limit of one (1) prize total during the Sweepstakes Periods per person. Anyone selected as a winner of a Sweepstakes Period will be ineligible for all subsequent Sweepstakes Periods.

RANDOM DRAWING: On or about the day immediately after the conclusion of each respective Sweepstakes Period (i.e., on November 5, 12, 19, 26, 2021), Sponsor will randomly select two (2) potential Prize winners from all eligible Entries received prior to the end of the applicable Sweepstakes Period – 1 from Instagram and 1 from Twitter. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZE, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Prize: A \$200 gift card (“Prize”) purchased from the restaurant tagged in the winning post. If the restaurant does not offer gift cards, Sponsor award the winner a prize of equal or greater value, as determined in Sponsor’s sole discretion. There are two (2) Prize per Sweepstakes Period (i.e. per Sweepstakes).

B. Total ARV: \$200 USD.

C. Odds of Winning: The odds of winning a Prize depend on the number of eligible Sweepstakes Entries received during the Sweepstakes Period.

D. General Conditions: In no event will more than two (2) Prizes be awarded per Sweepstakes. If, for any reason, more prize notifications are sent (or more claims are received) Sponsor reserves the right to award the Prize through a random drawing from among all eligible prize claims received. No prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute the Prize, with a prize of equal or greater value in case of unavailability of the Prize.

6. HOW TO CLAIM A PRIZE: The potential winner will be notified on Instagram or Twitter by a Direct Message from @RestaurantsCare with instructions on how to claim the Prize (each, a “Notification”). The potential winner must respond to the Notification within twenty-four (24) hours or they may, at the Sponsor’s sole discretion, be disqualified. Winner will be required to present U.S. identification and, if applicable, complete and sign for Sponsor an Internal Revenue Service (IRS) W9 with winner’s social security number and other personal information. Sponsor will use the W9 to report to the IRS the value of prize given to winner. Sponsor may send winner an IRS 1099 for tax reporting purposes by winner. All taxes are winner’s responsibility. The Sweepstakes Entities shall not be held responsible for any delays in awarding the Prize for any reason. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept a Prize, or the winner Notification is returned as undeliverable or the potential winner fails to respond to the winner Notification within the timeframe specified in such winner Notification, or if the potential winner does not answer the initial Notification, the Prize may be forfeited, except where prohibited by law. Sponsor will use the W9 to report to the IRS the value of prize given to winner. Sponsor may send winner an IRS 1099 for tax reporting purposes by winner. All taxes are winner’s responsibility.

If Sponsor requires the potential winner to sign a W9, the potential winner (and/or winner’s parent or guardian) must return the signed W9 and provide all other requested information and documents to Sponsor within two (2) business days following the date and time that Sponsor sent the W9 to the

potential winner. Failure to comply with this deadline may result in forfeiture of the Prize and selection of an alternate winner. If the Prize is won by a minor, the Prize may be awarded by Sponsor in its sole discretion to or in the name of the minor's parent or legal guardian. In its sole discretion, Sponsor may also require the potential winner to provide Sponsor with valid government-issued photo identification (or, if a minor without valid government-issued photo identification, the minor's parent or legal guardian must provide his or her valid government-issued photo identification).

LIMITATION OF LIABILITY: By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities, Instagram, Twitter and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each of their respective officers, directors, stockholders, employees, representatives, designees and agents, and Instagram, Twitter Inc., ("Released Parties") are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a Prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. If, for any reason, the Sweepstakes is not capable of running as planned, Sponsor reserves the right, at its sole and absolute discretion, to cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of a winner in a manner it deems fair and reasonable, including the selection of a winner from among eligible entries received prior to such cancellation, termination, modification or suspension, to the extent permitted under law. In no event will more prizes be awarded than are stated in these Official Rules. In the event that, due to technical,

typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner. Notice of such cancellation, termination, or modification of the Sweepstakes shall be posted at www.thegratefultablelineout.org.
